Prime Minister Evelyn Wever-Croes

Mrs. Evelyn Wever-Croes, LL.M. is the current Prime Minister and Minister of General Affairs, Integrity, Energy, Innovation, and Government Organization for the Dutch Caribbean island of Aruba. Aside from forming the first coalition government in over 20 years, she made history by being the first female Prime Minister of Aruba. After assuming the role of Prime Minister of Aruba, the big innovation gap and its impact on the Aruban economy became apparent. Therefore, the vision of Aruba's new Government is to achieve socio-economic resilience by accelerating the innovation capacity of the island through a human-centered approach, putting the Aruba people at heart of all policies.



H.E. Hennyson Thielman, Commissioner Bonaire

Mr. Hennyson Thielman is the current commissioner concerning economic development, finance and tourism for the Dutch Caribbean island of Bonaire. He studied business administration with a specialization in entrepreneurship in the Netherlands and decided to come back to Bonaire to contribute in making it more resilient and sustainable. Like many countries and islands across the world, the COVID-crisis brings big challenges to Bonaire. At the same time, it also brings many opportunities. By fostering the creativity and innovation power of people, Hennyson is convinced Bonaire will become the first Blue Destination in the world.



Ewald Biemans, Owner and CEO of Bucuti & Tara

Ewald Biemans is the owner and CEO of the Bucuti & Tara Beach Resort on Aruba as well as a board member of the Aruba Hotel and Tourism Association (AHATA). Mr. Biemans is highly involved in the tourism industry to encourage resorts on-island to become more eco-friendly.
